Secretary / Section Officer of the Board or the Asstt. Commissioner of the Kendra Vidyalaya Sangathan or the Deputy Director, Navodaya Vidyalaya Samiti in India or an officer of the Board at the Head Quarters and by the First Secretary/Attache/Cultural Attaché or an equivalent officer of the Embassy/High Commissioner of India in the concerned country in respect of students studying in an affiliated school of the CBSE situated outside the country and the student shall not be admitted to a school without such a counter signature.
